RE: California Electronics Waste Recycling Act and Proposition 65 for TCL Products

Dear Customer,

As you are aware, California has adopted the Electronic Waste Recycling Act of 2003 ("Recycling Act") to establish a funding system for the collection and recycling of certain electronics products, and the Safe Drinking Water and Toxic Enforcement Act of 1986 more commonly known as Proposition 65 ("Prop 65") to provide warnings for Californians about the potential exposure to certain chemicals. Under these California laws, manufacturers of certain products are required to provide written notice of certain specific information to retailers on an annual basis. This letter is intended to cover this requirement.

The Recycling Act

In addition to stringent design and reporting requirements, the Recycling Act requires manufacturers to provide written notice to retailers that certain products are covered under the Recycling Act and that a Covered Electronic Waste Recycling Fee must be collected upon the sale of those products. The fee applies to new and reconditioned products that are supplied to you by the manufacturer.

This letter serves as TTE Technology, Inc. dba TCL North America's ("TCL") notice that the products listed on the attached table are covered by the Recycling Act and subject to the fee. While the table represents our efforts to include all current model numbers, this fee is applicable to retail sales of all models within the impacted categories.

The collected fees must be remitted to the State of California quarterly on or before the last day of the month following the end of each calendar quarter. As a retailer of electronic devices, you are responsible for collecting the fee regardless of whether you received a notice from the manufacturer. Please note that the amounts for each fee were updated effective January 1, 2020. Please note that if you distribute TCL-branded products to other distributors and/or retailers within the State of California, you must pass on to them this information so that they can fulfill their obligations under this law.



California Proposition 65

In 2019, Prop 65 was amended and several parts of the law were updated including the sections covering consumer product exposure warnings required under certain circumstances by manufacturers and retailers. TCL provides Prop 65 warnings on its product packaging, under which safe harbor language specifically provided by the State of California appears on each product package. In certain circumstances, retailers are required to provide point-of-sale notices for consumers at all store locations, or in the case of internet sales the Prop 65 warnings should be posted online so consumers can make informed decisions about each product.

This letter is a reminder that TCL has provided applicable Prop 65 safe harbor language on its product packaging, and has made this information available to its retailers to enable full compliance for all retail store and internet sales. Please ensure that applicable Prop 65 safe harbor language provided at the retail point of sale or on internet retail pages matches the corresponding product packaging.
